9.3 Club Membership

- 1. Member clubs of GWR shall be those clubs, currently members of Pétanque England, which have their principal and regular playing base located on or within the geographical boundary as specified as The Great Western Region.
- 2. In exceptional circumstances a club based outside the GWR boundary may, by formal application process, be considered for

membership.

- 3. Any such application shall be made on behalf of that club by at least two of its club officers and submitted in writing to the GWR management committee, clearly stating the reasons behind the request. The GWR committee shall have the authority to outrightly refuse the request. Should the GWR committee feel that the application is provisionally acceptable, it will be forwarded, for due consideration, to each of the current GWR member clubs, along with the full and complete content of the letter.
- 4. Within the time period specified, an officer representing the members of each of those clubs, shall cast a vote of agreement or otherwise in respect of the said application. The application will be accepted where at least 80% of those cast are in favour.
